First, some background: On 22nd December 2007, Jim Berg warned Members of this Report of the potential for a bear market or crash in Edition 130. Jim also explained the criteria he was looking for at that time to flag an overall market exit.

Two weeks later, Jim's exit signal was triggered, so he closed his own and this Report's notional short term trading portfolio and 'switched to ca\$h'.

In March 2009 we 'rang the bell' in this Report and said that:

- i) We thought the market had 'bottomed' but we needed confirmation before re-entering as we do not believe in 'bottom fishing'
- ii) It would take about 3 months after the bottom for a confirmed re-entry signal using Jim's rules on weekly, then daily charts

3 months later, Jim notified Report Members of an overall market re-entry -- in June 2009.

Those Members who followed Jim's lead and who stayed in ca\$h for those 18 months did **NOT** lose literally millions of dollars between them*.

Over those 18 months, now referred to as the 'Global Financial Crisis' (GFC), Jim tested a few hundred 'Experts' Picks' including '18 Safe Starter Stocks', chosen specially for 'mums and dads' investors.
